- This document outlines the fees for the following BRE Global Ltd certification schemes:
  - BREEAM Infrastructure (formally CEEQUAL) Version 6 for projects (new construction and refurbishment)
  - BREEAM Infrastructure (formally CEEQUAL) Version 6 for Term Contracts
- It covers fees for both UK and International Schemes.
- This fee sheet shall be read in conjunction with TC501 BREEAM Infrastructure Terms and Conditions of Business.
- All fees quoted in this fee sheet will be invoiced to the named applicant on the registration form and invoiced in GBP (£).
- This fee sheet shall be used for all registrations made to BREEAM Infrastructure Version 6 from 1st July 2022 onwards.

## TRAINING, QUALIFICATION AND LISTINGS

- Successful completion of a scheme course, including passing the examination or test, qualifies candidates to act as a BREEAM Infrastructure assessor. However new assessors will be subject to a higher level of review in their first assessment that is submitted for verification. A fee is payable for this as listed in the Other Scheme Related Charges section.
- There are no Assessor licence fees within BREEAM Infrastructure. However, should an Assessor wish to be listed on the public register of assessors on GreenBookLive there is an annual fee as stated in the Other Scheme Related Charges section.

## General notes

- Any registration fees already invoiced are non-refundable.
- Assessments must be undertaken by a qualified BREEAM Infrastructure assessor.
- This fee covers:
  - Completion of the scoping of the BREEAM Infrastructure criteria to the nature of the project being assessed by BRE Global and their appointed BREEAM Infrastructure Verifier.
  - technical query support/resolution from both the Verifier and BRE Global.
  - access to the online assessment tool (BREEAM Projects) for completion and submission of the assessment.
  - making the certification decision, preparation of certificates and presentation.
  - submission of a case study to the BREEAM Infrastructure website.
  - scheme administration, maintenance and development costs.
  - associate membership of Constructing Excellence's Sustainable Infrastructure Group.
- The project value quoted in the fee scale shall be the overall construction value of the project being assessed. The construction value is the total project cost less land purchase costs, legal and planning fees, and other risk/contingency fees. When the registration is made before contract award the value used shall be the current estimated construction value.
- Any variations to the registration, whether a change in type of award or escalation in the project value, shall be in accordance with the fee scale current at the date the variation is agreed. Fees will not be reduced in the event of a reduction in project value. An administration charge may be made for such changes as listed in the Other Scheme Related Charges section.
- If a project significantly changes its nature, context and/or scale, or the assessment type is changed, after the scoping out meeting has been completed the project may need to be re-scoped. If so a rescoping fee may be charged depending on the scale of changes to the project as listed in the Other Scheme Related Charges section.
- In the event that the Project or any verification made under that project is delayed in excess of 12 months then BREEAM Infrastructure, may amend or adjust the fees quoted to bring it in line with the current Fee Scale at the time of verification.
- BRE Global Ltd reserve the right to add an additional fee to cover inflation for projects of more than three years duration. Inflation will be calculated and applied to any instalment that becomes due more than 3 years after the date of registration. However, where a purchase order is raised by the applicant for the full registration fee at the time of registration no inflation costs will be applied.

## Whole Project Assessments

- For projects up to £30m the registration and management fee is payable in full at the time of registration. Above this project value fees may be paid in instalments as indicated in the fee scale.
- If a project is initially registered after the commencement of design, the initial registration and design instalments are payable at the time of registration. If a project is registered after commencement of construction, the whole registration fee is payable at the time of registration.
- For assessments that are split into multiple design and/or construction sub-assessments the instalments are due on the earliest planned design and construction commencement dates.

## Strategy and Design, and Design and Construction Assessments

- For projects up to £30m the registration and management fee is payable in full at the time of registration. Above this project value fees may be paid in two equal instalments, 50% on registration and 50% on commencement of design or construction stages as applicable.
- If a project is initially registered after the commencement of design, for strategy and design assessments, or after commencement of construction, for design and construction assessments, then the full registration fee is payable at the time of registration.

## Design only and Construction only Assessments

- Design only and Construction only assessments are charged at 80% of the fee in the table above.
- All registration fees are payable in full at the time of registration.

## General notes

- Verification fees are invoiced at the time of submission of an assessment by the BREEAM Infrastructure assessor for verification.
- The fee payable shall be that current at the time of submission of the assessment for verification.
- This fee includes:
  - The verification of the assessment by the appointed Verifier, including their travel time to and from the verification meeting within the UK
  - Where indicated in the table travel time of the appointed Verifier to and from a meeting outside the UK.
  - Ratification of the verified assessment by BRE Global Ltd.
- For UK assessments the fee also includes travel expenses for the verifier in attending the verification meeting. For international assessments travel expenses will be charged in addition to the fees above and will be charged at cost.
- For international assessments, BRE Global Ltd will usually require the appointed Verifier to visit the project and undertake a face-to-face verification. This will usually occur during construction stage. Strategy and design verifications will usually be conducted remotely via web conference. If required design stage verifications can be conducted face-to-face. If more than one face-to-face verification is required additional fees will be payable.
- Verification fees are charged based on the overall construction value of the project. If an assessment is being split into multiple sub-assessments the appropriate verification fee is payable for each separate sub-assessment.
- The combined verification fee is charged for whole project, design and construct and client and design assessments where only the single mandatory verification at the end of the assessment is undertaken.
- Generally, the strategic stage verification should be of the assessment for the whole project. Where the project is then split into multiple sub-assessments, the verified strategy score shall be added to each assessment.
- The interim design verification is intended to be conducted at the point a project design is frozen for tendering a design and construct contract. An interim design assessment can only be undertaken as part of a whole project assessment. In other situations, the design verification should be at the end of the design phase.
- Where discussions during the verification process identify that additional evidence is available. Up to 10 credits can be re-reviewed by the appointed Verifier free of charge if resubmitted within an agreed timeframe with the Verifier. Should the number of credits requiring additional evidence exceed 10, a charge will be made for this re-verification.
- After this agreed timeframe has passed the Verifier will submit the assessment for ratification. Should the assessor or applicant wish to submit additional evidence at any point after this, they will be charged as detailed in the Other Scheme Related Charges section shown below.
